They can be financial and nonfinancial companies. <i>iHome Mortgage only shares your information to nonaffiliates so they can originate, process and/or close your loan. This would be wholesale lenders, title companies, AMC's, or any other service provider.</i>	
Joint marketing	 A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <i>iHome Mortgage does not jointly market.</i>
